- **11.** Financial report by the City Manager.

The City Manager gave his report as follows:

Sales Tax is down 10.67% from last month and up 12.48% from the same month last year. The use tax is down 49.09% from last month and down 18.18% from the same month last year. Other revenues are down 8.70% from last month and down 15.39% from the same month last year. Transfers-in from MUA are up 4.91% for last month and up 60.87% from the same month last year.

Overall revenues are \$188,929.97, which is down 14.15% from last month and up 25.27% from last year. Expenditures are \$143,654.34 which is down 45.08% from last month and down 16.23% from the same month last year. Leaving the fund balance for the month at a positive \$45,275.63.

Mangum City Commission 5-7-2020 Special Meeting Page 2 of 3 MUA Revenues were \$303,940.06 which is down 8.57% from last month and down by 11.79% from the same month last year. MUA expenditures are \$342,639.40 which is down 15.05% from last month and down by 14.14% from the same month last year. Leaving the fund balance for the month a negative \$38,699.34. Balance of Revenues vs. Expenditures from July to January 2020.

General Government: \$283,115.24, Mangum Utility Authority: \$-13,554.31.

Commissioner Webb asked if he knew what the budget shortfall will be for the year end.

City Manager Andren said he does not think we will have a short fall in the General Fund but a small one for MUA.

- 12. Discussion and possible action to elect a Vice Mayor. Motion by WEBB and seconded by BOWMAN to elect Ron Gay for the Vice Mayor. Mayor Scott called for the vote recorded as follows: AYE: Bowman, Reese, Webb, Gay NAY: None Motion passed 4-0.
- 13. Discussion and possible action for Mangum High School Graduation Ceremony. Commissioner Reese explained that the school has put together an 8-member committee to honor the class of 2020.

They will be having a Senior Parade. Each senior can have 1 or 2 vehicles or a vehicle with a trailer. At the end of the parade in front of the Mangum High School for the presentation of the diplomas. Students will have their name called, walk across the stage, receive their diploma, and return to their vehicle.
