The City Manager gave his report as follows:

Sales Tax is up 24.31% from last month and down .03% from the same month last year. The use tax is up 78.30% from last month and up 82.98% from the same month last year. Other revenues are down 20.05% from last month and down 44.72% from the same month last year. Transfers-in from MUA are down 4.68% for last month and up 53.34% from the same month last year.

Overall revenues are \$190,820.55, which is up 1.00% from last month and up 10.41% from last year. Expenditures are \$186,157.58 which is up 29.59% from last month and up 5.03% from the same month last year. Leaving the fund balance for the month at a positive \$4,662.97.

MUA Revenues were \$318,573.30 which is up 4.81% from last month and up by 5.21% from the same month last year. MUA expenditures are \$357,621.79 which is up 4.37% from last month and up by 14.91% from the same month last year. Leaving the fund balance for the month a negative \$39,048.49.

Balance of Revenues vs. Expenditures from July to April 2020.

General Government: \$287,778.21, Mangum Utility Authority: \$-52,602.80.
