The City Manager gave his report as follows:

Sales Tax is down by 4.61% from last month and down by 4.67% from the same month last year. The use tax is up by 43.77% from last month and up by 43.42% from the

same month last year. Other revenues are up 20.96% from last month and up by .19% from the same month last year. Transfers-in from MUA are the same as for last month and up 53.34% from the same month last year.

Overall revenues are \$193,632.26, which is up by 134.58% from last month and down 23.86% from last year. Expenditures are \$250,175.44 which is up by 95.02% from last month and up by 43.02% from the same month last year. Leaving the fund balance for the month at a negative \$56,543.18.

MUA Revenues were \$367,7590.64 which is up by 24.29% from last month and up by 10.15% from the same month last year. MUA expenditures were \$354,277.57 which is up by 64.93% from last month and down by 13.32% from the same month last year.

Leaving the fund balance for the month a positive \$12,982.07. Balance of Revenues vs. Expenditures from July to May 2020.

General Government: \$185,494.61/\$165,038.67 (Incode), Mangum Utility Authority: \$41,055.42/(141,032.68) (Incode).
