She went over several areas of the audit and explained what they meant. She explained where you could see the General Fund as well as all the other funds. Overall everything looks good.

8. Financial report by the City Manager.

The City Manager gave his report as follows:

Sales Tax is up .3.08 from last month and down 8.93% from the same month last year. The use tax is up 33.50% from last month and down by 4.23% from the same month last year. Other revenues are down 52.56% from last month and up 23.41% from the same month last year. Transfers-in from MUA are the same as last month and up 48.94% from the same month last year.

Overall revenues are \$205,454.06 which is up by 10.22% from last month and up by 22.27% from last year. Expenditures are \$191,458.87 which is up by 7.29% from last month and down by .77% from the same month last year. Leaving the fund balance for the month at a positive \$13,995.19.

MUA Revenues were \$428,800.59 which is down by 13.19% from last month and up by 7.50% from the same month last year. MUA expenditures are \$393,785.57 which is down by 14.78% from last month and down by 3.78% from the same month last year. Leaving the fund balance for the month a positive \$35,015.02.

Balance of Revenues vs. Expenditures from July to October 2019)

General Government: \$148,476.55, Mangum Utility Authority: \$135,961.47.
